Michael J. Fucci '80

Mike Fucci is an experienced board leader and executive with 40 years as a practitioner and principal at Deloitte, including four years as the executive chairman of the board of the Deloitte US Firms. Before retiring as chairman and principal of Deloitte, Mike provided governance and operational leadership on priority matters such as strategy, leadership succession, risk mitigation, talent development, executive performance and compensation. He also led client engagements and is a thought leader within the HR consulting market – particularly in the areas of talent strategies,

succession management, HR transformation, and health-care merger integration.

Mike was elected chairman of the Deloitte US Board of Directors in 2015. During Mike's tenure as chairman, the Deloitte US Firms' revenue grew 19% to \$19B, and headcount grew 25% to over 5,500 partners and directors, and 100,000 employees. He redefined and communicated a clear vision of the role of the board as a governing body that upholds reputational excellence, cultivates leaders and successors, and capitalizes on individual differences.

Mike established and co-chaired the Board Leadership Forum, a coalition of Fortune 500 board chairs and lead directors who convene to discuss research, trends and perspectives pertinent to today's evolving business environment. He also served as chair of the Deloitte Foundation providing strategic oversight of a not-for-profit organization, which supports education initiatives in the U.S.

Mike promotes the benefits of leader-led sponsorship and diversity on boards. He served as a sponsoring executive for the U.S. 30% Club and participated as a mentor in their cross-industry mentoring program for high-talent women seeking corporate board positions. He has written and spoken extensively on these topics including features in Fortune, Huffington Post, NACD, CNBC and at numerous universities and conferences.

Mike attended Montclair State University, where he earned a Bachelor of Science in mathematics. He was a member of the National Association of Corporate Directors (NACD), and an executive board member of the Council for Competitiveness. He supports the New Jersey Performing Arts Center by serving on the board of directors and as a member of the Human Resources committee. A 35-year veteran of NBCUniversal Media, LLC, Denise has held various positions in sales, news and programming at WNBC-TV. She is an account manager in the sales unit of NBCUniversal Owned Television Stations.

Denise recently completed two consecutive two-year terms as president of the New York Chapter of The National Academy of

Television Arts and Sciences. In her 37 years as a member, she was elected to the Board of Governors of the New York chapter and also served as secretary and treasurer. Denise was elected as a trustee at the national level of the Academy for two terms, and was chair of the Moving Forward: Daytime Emmy® Awards Committee.

Skating has been a passion for most of Denise's life. She remains active with U.S. Figure Skating, a governing body of the U.S. Olympic Committee. She has attended 23 World Figure Skating Championships, and several Winter Olympics. With her combined skating and media background, Denise often shares insight and ideas with skating officials on broadcasting and advertising matters.

Faith and philanthropy are important pillars to Denise. She serves on multiple committees for the Archdiocese of Newark, New Jersey, and was appointed to the Board of Overseers at Seton Hall University/Immaculate Conception Seminary. Al graduated from Montclair State as a broadcasting major in 1984. Remaining connected to his alma mater, he gives back as a donor and by serving on the College of the Arts Advisory Board as well as the board for the School of Communication and Media.

Passionate in her support of education, social services and the arts, Rose Cali has distinguished herself as a decades-long advocate for community partnerships and educational causes. As a philanthropic leader, she is a well-known "connector," helping form partnerships between the many community organizations to which she devotes her time and talent.

A proud alumna of Montclair State University, Rose has kept close ties to the University and is intent on helping hardworking students from working-class families, what she feels embodies Montclair State's legacy. She has served the University in many capacities, getting involved in 1991 as a University Board of Trustees member and remaining active on the University and Foundation boards, serving as co-chair for multiple fundraising campaigns and advisory boards, and serving on the John J. Cali School of Music Advisory Board. She is the founder, former president and CEO of the Yogi Berra Museum and Learning Center on campus, one of her most satisfying accomplishments.

Her loyalty and love for the University is a legacy through an endowed gift for music student scholarships that Rose and her late husband, John, established. Through the John J. Cali School of Music, the Cali family's generous support has forever changed the University's music program, improving its growth and excellence and transforming hundreds of students' lives through scholarships so they can deepen their passion for music and the arts and serve the community as performers, educators, scholars, music therapists and more.

She dedicates herself to many causes and is committed to the Montclair community, serving on the Montclair Art Museum (MAM) Board of Trustees, currently as board cochair, and co-chairing the successful MAM Second Century Campaign, helping raise \$12.5 million. She has worked on numerous fundraising efforts for the Montclair Public Library, including in 1993 when she launched and managed "Booktoberfest" and cochaired the Library's \$2.5 million capital campaign. Her extensive board service includes: Montclair Film Festival; Newark Mentoring Movement; the New Jersey Coalition for Inclusive Education; NJPAC Arts Education Committee and Women's Association of NJPAC; St. Joseph's Children's Hospital; Liberty Science Center; National Italian American Foundation; Big Brothers Big Sisters of New Jersey and Essex, Hudson and Union Counties; Mental Health Association of Essex County; YWCA Montclair; Salvation Army of Montclair Advisory Board; Montclair Kimberly Academy; Unity Concerts of New Jersey; and Luna Stage.

As a young child, she learned firsthand the importance of helping others as the Salvation Army helped her mother raise her family in New Haven, Connecticut. Rose graduated magna cum laude from Montclair State University in 1980 with a Bachelor of Arts in Cultural Anthropology. She lives in Montclair and has five children and 11 grandchildren.
