

Once the Form I-20 has been processed, the student will receive an email informing them that it has been issued and it can be downloaded through the application portal.

As an international student pursuing a degree program, you likely need to apply for an F-1 or J-1 student visa, which allows for full-time study in the U.S. If you already have an active F-1 student visa status, you will need to have your existing F-1 record transferred to Montclair State University. To apply for an F-1 or J-1 student visa or to transfer your existing F-1 record, it is required that you apply for an I-20/DS 2019. You can submit your I-20/DS 2019 application materials using the submission form below. The following are required:

- Application for Form I-20 or DS-2019/Affidavit of Support
- Financial Documents/Letter of Sponsorship
- Passport (biographical/information page only)

Third party sponsors: If you are being sponsored by an organization that will provide the J-1 sponsorship for you (such as Fulbright), you do NOT need to take any further action and should not submit the documents noted above. They will issue your DS-2019 for you.
